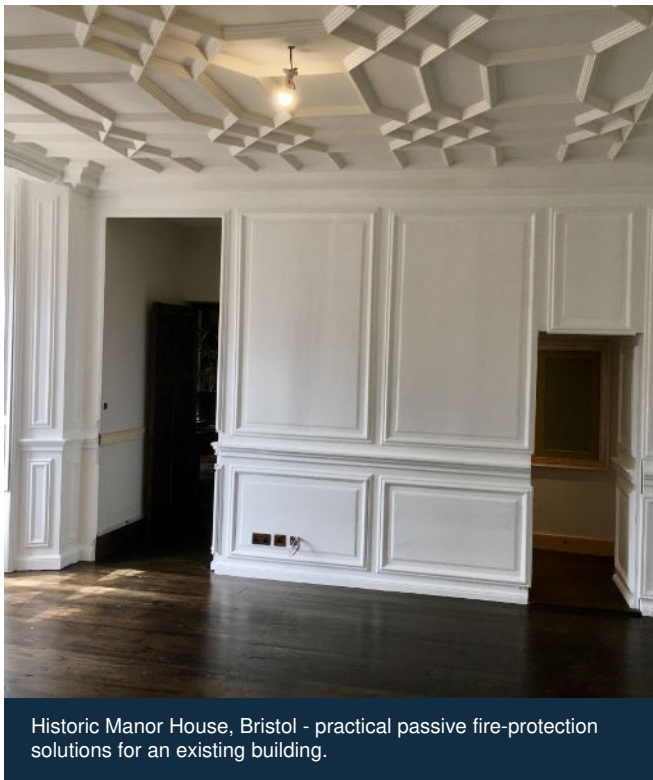

A clearly defined service

Comprehensive protection for building and M&E services

- Fire-stopping to pipes, cables, trays and building-service penetrations
- Fire-rated barriers to roof voids, under floors and concealed cavities
- Protection to structural steel using suitable intumescent coating systems
- Intumescent coatings to suitable timber, walls, ceilings and historic panel doors
- Remedial compartmentation and maintenance work arising from fire-safety reports
- Supply of passive and intumescent products from reputable manufacturers

Every proposed detail must be matched to the supporting construction, service type, opening size and required fire resistance - there is no universal fire-stop detail.

Protecting escape routes

Fire doors are critical to controlling smoke and fire spread. We inspect existing doors, identify defects and recommend proportionate remedial work. Where upgrading is unsuitable, we can advise on or install a new fire doorset to the agreed specification.
